Executive Order No. 20-04

COVID-19 GOVERNMENT EMPLOYMENT LIMITED WORKFORCE MODE

WHEREAS, the Pascua Yaqui Tribe has been carefully monitoring the COVID-19 situation and the guidance from the Centers from Disease Control (“CDC”); and

WHEREAS, on March 17, 2020, the Tribal Council passed Resolution No. C03-66-20 which declared a tribal emergency concerning COVID-19 and provided emergency authority regarding COVID-19; and

WHEREAS, on May 27, 2020, the Tribal Council passed Resolution No. C05-121-20 which enacted a Coronavirus Protection Ordinance in response to the COVID-19 pandemic, which was subsequently amended on June 10, 2020; and

WHEREAS, the public health and safety of our community remain the Tribal Council’s primary concern; and

WHEREAS, despite sustained efforts, COVID-19 cases have recently increased in the State of Arizona; and

WHEREAS, further efforts to control the spread of the virus to reduce and minimize the spread of infection in the community are needed; and

WHEREAS, in consultation with the Tribal Council and the Incident Command System, I have determined that it is in the best interest of the health and safety of our tribal members to issue this order directing that the Tribal Government enter into a limited workforce mode; and


NOW THEREFORE, I, PETER S. YUCUPICIO, in accordance with Resolution No. C03-66-20 do hereby issue the following order:

IT IS HEREBY ORDERED THAT:

- 1) The Pascua Yaqui Tribal Government workforce shall immediately enter a limited workforce mode in order to combat the COVID-19 pandemic. Each Department shall develop and implement the limited workforce plan immediately if possible, but in no event later than July 20, 2020.
- 2) Essential services as determined by the Tribal Council shall remain open.
- 3) The Departmental limited workforce plans shall be reviewed by Tribal Council every 30 days to determine whether any changes are required.



- 4) Departments shall ensure that the Department contact numbers attached at Attachment A are answered during normal business hours and that messages are promptly returned.
- 5) This Order shall remain in effect until further notice.
